

FBI hunts for would-be assassin's motive

AS A STARTLED nation confronts its violent politics, a crucial week in a remarkable presidential election will dawn on Monday with both President Biden and former President Donald J Trump trying to find their way back to a campaign irrevocably changed by an attempted assassination.

Biden addressed the nation on Sunday night with a plea: "We can't allow this violence to be normalised." Secret Service officials defended their actions while facing accusations of negligence and a promise from congressional Republicans to investigate the failures that left Trump grazed by a bullet, a rallygoer in western Pennsylvania dead and two others gravely injured. Law enforcement officials were still struggling to determine the motive of the gunman, Thomas Crooks, who opened fire from a building just outside the security perimeter of the campaign rally where Trump was speaking on Saturday in Butler.

But it will be Trump's return to the national stage iust two days after a would-be assassin left him bloodied but defiant — that will test whether he and his followers will embrace appeals for unity or instead use the shooting to amplify their calls for revenge and retribution.

In Milwaukee today the Republican National Convention will kick off, and delegates will officially nominate Mr Trump for the presidency under the most extraordinary of circumstances. The convention will be the coronation Mr Trump always wanted, after his 2016 struggles in Cleveland with backers of Senator Ted Cruz of Texas and after the Covid-19 pandemic of 2020 forced the party into a truncated conclave at the White

GOOGLE PARENT ALPHABET is in talks to acquire cybersecurity startup Wiz, according to a person familiar with the matter.

Adeal may be worth as much as \$23 billion, said the person, who asked not to be identified discussing nonpublic information.That would make it the tech giant's largest acquisition to date. An agreement hasn't been reached and talks could still end without one, the person said.

A representative for Alphabet didn't respond to requests for comment. A spokesperson for Wiz declined to comment.

Alphabet already owns the cybersecurity firm Mandiant, which it bought for \$5.4 billion two years ago in its secondlargest acquisition, topped only by its deal for Motorola Mobility Holdings LLC completed in 2012. An acquisition target as large as Wiz would be unusual for a big tech company like Alphabet and may draw even more scrutiny from antitrust regulators.

Google already faces several antitrust challenges, including a lawsuit by the US Justice Department accusing it of abusing its dominant position in online search and another one regarding its digital advertising tools.

The Wiz talks, which were previously reported by the Wall Street Journal, come on the heels of Alphabet shelving efforts to acquire customer relationship management company Hub-

New York-based Wiz connects to cloud storage providers such as Amazon Web Services and Microsoft Azure and scans data stored there for security risks. The company, founded in 2020, was valued at \$12 billion during a May funding round that drew investors such as Andreessen Horowitz, Lightspeed Venture Partners and Thrive Capital.

The acquisition of Wiz could help Google catch up to Microsoft and Amazon.com in an increasingly competitive cloud market. Alphabet has been ramping up investment in its cloud customer business,

including offering more generative artificial intelligence tools for clients. Though Google still lags behind Microsoft and Amazon in the market for cloud com puting, the company reported that its cloud unit has been profitable in consecutive quarters, after years of the unit being a money-losing operation. Opportunities are growing

in the space as more startups move their apps and data to the cloud, particularly for generative AI purposes. Artificial intelligence tools are trained off of enormous data sets and often require vast amounts of compute power to generate content such as images, marketing campaigns or software code. An Alphabet takeover of Wiz

also stands to intensify Google's competition against Microsoft the world's largest seller of cybersecurity products Microsoft has been hit with a series of embarrassing hacks that have exposed corporate and government customers in recent years. A US government report blasted the company earlier this year for its failure to stop hackers tied to the Chinese government from pilfering the email boxes of US officials.





DONALDTRUMPWON a major legal victory on Monday when a federal judge dismissed one of the criminal prosecutions against him, as he prepared to accept the Republican Party's presidential nomination just days after surviving an assassination attempt.

A US judge in Florida appointed to the bench by Trump dismissed the case that accused the former president of illegally holding on to classified documents after leaving office, ruling that the prosecutor handling the case was unlawfully appointed to his role.

The news comes at outset of the 2024 Republican convention in Milwaukee, where Trump will announce his vice presidential pick and on Thursday is due to formally accept the party's nomination to challenge Democratic President Joe Biden in the November 5 election.

Trump, 78, and Biden, 81, are locked in what opinion polls show to be a tight election rematch. Trump continues to falsely claim that his 2020 loss to Biden was the result of widespread fraud and has not committed to accepting the results of the election were he to lose.

Alphabet is in talks to acquire Wiz for \$23 bn

GOOGLE PARENTALPHABET is in talks to acquire cybersecurity startup Wiz, according to a person familiar with the matter.

Adeal may be worth as much as \$23 billion, said the person, who asked not to be identified discussing nonpublic information. That would make it the tech giant's largest acquisition to date. An agreement hasn't been reached and talks could still end without one, the person said.

A representative for Alphabet didn't respond to requests for comment. A spokesperson for Wiz declined to comment. Alphabet already owns the cybersecurity firm Mandiant, which it bought for \$5.4 billion two years ago in its secondlargest acquisition, topped only by its deal for Motorola Mobility completed in 2012. An acquisition target as large as Wizwould be unusual for a big tech company like Alphabet and may draw even more scrutiny from

antitrust regulators. Google already faces several antitrust challenges, including a lawsuit by the US Justice Department accusing it of abusing its dominant position in online search and another one regarding its digital advertising tools.

The Wiz talks, which were previously reported by the Wall Street Journal, come on the heels of Alphabet shelving efforts to acquire customer relationship management company HubSpot.

जीटीबी अस्पताल में हत्या का मामला

दो आरोपी चढ़े पुलिस के हत्थे

जनसत्ता संवाददाता नई दिल्ली, 15 जुलाई।

दिल्ली के जीटीबी अस्पताल के एक वार्ड में मरीज की हत्या के मामले में पुलिस ने दो लोगों को गिरफ्तार किया है। अधिकारियों ने सोमवार को बताया कि पुलिस ने फैज (20)

को उत्तर प्रदेश के लोनी से और फरहान को दिल्ली के चौहान बांगर इलाके से पकड़ा।

हालांकि, पुलिस ने कहा कि हो सकता है कि ये दोनों रविवार को हुई गोलीबारी की घटना में सीधे तौर पर

ये घटना गलत पहचान का मामला हो सकती है, क्योंकि वारदात से एक दिन पहले उसी वार्ड से एक अपराधी को स्थानांतरित किया गया था। मृतक के परिवार ने भी दावा किया कि हत्यारा संभवतः किसी अपराधी को निशाना बनाना चाहता होगा। अधिकारियों ने बताया कि जीटीबी अस्पताल के वार्ड नंबर 24 के भीतर रविवार को एक किशोर ने रियाजुद्दीन (32) जांच के लिए कई दल गठित किए गए हैं। कुछ लोगों ने गोली मार दी थी और कुछ समय फहीम से मिलते हैं जो हासिम बाबा गिरोह का भी चौहान बांगर इलाके से पकड़ा गया।

घटना के विरोध में डाक्टरों ने की हड़ताल

इस घटना के बाद अस्पताल के रेजीडेंट डाक्टरों ने अपनी सुरक्षा को लेकर गंभीर चिंता जताते हुए अनिश्चितकालीन हड़ताल शुरू कर दी। रेजीडेंट डाक्टर्स एसोसिएशन (आरडीए) के अध्यक्ष नितेश कुमार ने बताया कि आरडीए के सदस्यों ने सोमवार को सुबह नौ बजे हड़ताल शुरू की, लेकिन

आपात सेवाएं जारी हैं। आरडीए के एक सदस्य ने बताया कि अस्पताल में चिकित्सक केवल आपातकालीन रोगियों का ही इलाज कर रहे हैं, जबकि बाह्य रोगी विभाग, प्रयोगशालाएं और अन्य विभागों में काम बंद है। आरडीए के एक प्रवक्ता ने पहले कहा था कि हमारी सुरक्षा बढ़ाए जाने की बार-बार की अपील को नजरअंदाज किया गया है जिसकी परिणति इस दुखद घटना के साथ हुई।

पुलिस अधिकारियों ने बताया कि फैज और फरहान कथित तौर पर चार आरोपियों को मोटरसाइकिल मुहैया कराने में शामिल थे। पुलिस ने बताया कि चारों आरोपी उस मोटरसाइकिल पर सवार होकर जीटीबी अस्पताल पहुंचे, जिनमें से एक ने वार्ड नंबर-24 में घुसकर मरीज पर गोलियां चलाईं, जिससे उसकी मौत हो गई।

पुलिस उपायुक्त (शाहदरा) सुरेंद्र चौधरी ने कहा कि हम उनसे (फैज और फरहान) पूछताछ कर रहे हैं और मरीज पर गोली चलाने वाले के बारे में पता लगाने के लिए दोनों का पुलिस रिमांड मांगेंगे। हमारी टीमें बाकी आरोपियों को जल्द ही पकड़ लेगी।

हमलावर एक गिरोहबाज को मारने के लिए अस्पताल गया था, जो हासिम बाबा गिरोह का की गोली मारकर हत्या कर दी। इस हत्या की प्रतिद्वंद्वी था। इस गिरोहबाज को 12 जून को उसके दो भाई-फौजान और मोइन खान अक्सर उन्होंने कहा कि एक और संदिग्ध फरहान को

के लिए उसी वार्ड में भर्ती कराया गया था. जहां हमलावर ने रियाजुद्दीन को गोली मार दी। पुलिस उपायुक्त ने बताया कि अस्पताल के पास लगे सीसीटीवी कैमरों की फुटेज खंगाली गई है, जिसमें चार लोग अस्पताल के आपातकालीन द्वार से प्रवेश करते दिखाई दे रहे हैं। टीम ने फुटेज में लोगों की पहचान की। उनके सोशल मीडिया हैंडल ढूंढे और उनके मोबाइल नंबरों की जांच की गई। हमने काल डिटेल की जांच की और कुछ और संदिग्धों की पहचान की गई। उन्होंने बताया कि काल डिटेल की जांच के बाद फैज को उत्तर प्रदेश के लोनी के लक्ष्मी गार्डन

प्रतिनिधिमंडल के साथ बैठक की। इसी पोस्ट में भारद्वाज ने कहा कि वह दिल्ली के पुलिस आयुक्त से अनुरोध करेंगे कि एक कांस्टेबल को चौबीसों घंटे ड्यूटी पर तैनात किया जाए। उन्होंने कहा कि ऐसे मामलों से जूझ रहे अस्पतालों की मानक संचालन प्रक्रिया (एसओपी) की समीक्षा की जाएगी।
